

Bensenville Water Park & Splash Pad Season Pass Registration, Household Proof of Residency and ID Requirements Water Park Pass & Household Policies

1. A Family Pass can only consist of parent(s) and their children under age 25 living in the same residence. A grandparent who can prove residency at that same address can be included on a Family Pass. Every household member must provide acceptable ID with the current address.
2. Adult children living with their parents cannot be put on a Family Pass once they turn 25 years old and are required to get an individual adult pass. If a person has a child while still living with their parents, this individual would need to get a separate Family Pass for themselves and their children.
3. A Couple Pass can be purchased by any two people living in the same household who can prove their residency. Unrelated persons in the same household are not eligible for any type of Family Pass.
4. Children ages 2 and under do not require a pass, but must present a birth certificate to verify age. A child living with the family cannot be put on a Family Pass unless they can prove legal custody. Age for pass sale purposes will be defined by age on Opening Day of the Water Park.
5. A child-care provider is not considered part of the household, even if living at the residence. They would need to purchase an individual pass and prove residency with 3 pieces of mail to that address to receive a resident rate for an individual pass.
6. Passes must be presented to the Water Park Cashier upon every visit. Passes and pass photos can only be secured at the Deer Grove Leisure Center. Lost passes can be replaced for a fee of \$7 only at the Deer Grove Leisure Center when it is open.

To Renew a Pool Pass

1. Pay the appropriate fee at Deer Grove Leisure Center. Registration hours are 8:30am – 6pm, Monday-Friday and 9am – 12pm on Saturday. You may also utilize drop-off registration at other times when the facility is open.
2. Children 17 and under are required to get a new pass photo at the Deer Grove Leisure Center every year. Adults and seniors with a current Bensenville Water Park or Fitness Center Pass can use that existing pass as a Water Park Pass once purchased. Bring in your old pass when you register.

To Purchase a New Pool Pass

1. If not already completed, residents and non-residents must update their household information at the Deer Grove Leisure Center. Residents must provide proof of residency. Every person who is getting a pass must show an acceptable ID. Types of acceptable ID and acceptable proof of residency are listed below.
2. Pay appropriate fee at the Deer Grove Leisure Center. Registration hours are 8:30am – 6pm Mon-Fri and 9am – 12pm on Saturday or as a drop-off registration at other times the facility is open.
3. Take pass photo at the Leisure Center. If family member is not present at time of purchase, they can get their pass photo taken at a later time at the Leisure Center and must present acceptable ID at that time.

Proof of Residency & Acceptable ID

Bensenville Park District residents: Must provide an acceptable form of picture ID with the current address listed. If the picture ID provided does not have your current home address, you must additionally provide an acceptable form of residency with current address (see below). If multiple, unrelated adults reside in the same household, each adult must provide the above information.

Non-residents: must provide an acceptable form of picture ID

Acceptable forms of picture ID (must have current address):

valid driver's license with current address, valid state ID with current address, foreign consulate ID with current address

Child Acceptable ID: birth certificate, passport, school ID or current report card.

Acceptable forms of residency (with current address):

current utility bill (gas, electric, water, or Comcast only), current mortgage, lease statement or property tax bill
